- Lessons from COVID-19 and Preparing for the Future

Dr. Jha will also address the vital importance of occupational safety, ensuring that as our first responders protect the public, they are also protected. Together, we will chart a path forward to enhance resilience and safeguard the health and safety of those who serve on the frontlines by focusing on preparedness, adaptability, and innovation. - Melanoma in the Fire Service
This lecture will focus on the high rate of skin cancer in the fire service, and how early detection, routine screenings and prevention can help fire fighters stay healthy. It will also examine the impact of how fire suppression duties and exposure to forever chemicals such

as PFAS, are negatively impacting our health. This lecture will examine what can be done to change this current health trajectory and decrease our risk. It will also discuss the importance of establishing a program within your department to spot skin cancer through screening and the adoptions of healthy lifestyle habits.

- **Reducing The Burden of Cancer Through Earlier Detection and Intervention**
This lecture will examine how the Dana-Farber Cancer Centers for Early Detection and Interception represent a fundamental shift in cancer care, moving from a reactive to a proactive approach. Traditionally, most cancers are diagnosed when symptoms appear, often at advanced stages, leading to higher mortality rates. However, many cancers can be prevented by intervening on precursor conditions. At Dana-Farber, the aim is to prevent or intercept cancer before it starts. Their focus areas include early detection, comprehensive risk assessment, and timely interception, transforming the landscape of cancer care.
